2026 Code of Conduct

- Creates an environment and culture that is reflective of personal integrity and respect and that we are capable of enforcing rules upon ourselves with honesty, integrity, and good sportsmanship.
- The same integrity, honesty, and goodwill are expected whether on the golf course, in the clubhouse or present on any other portion of the property.
- Is free of discrimination or any form of harassing behavior toward fellow golfers, visitors, staff, or management.
- Acknowledges Southern Hills Golf Club facilities as a customer and family-friendly environment and refrains from using obscenities, excessively loud, or otherwise inappropriate behavior.
- Observes proper etiquette on and off the golf course and when present at any portion of the facility.
- Shows the utmost respect and dignity to fellow golfers, visitors, staff, and management.
- Demonstrates an understanding that golfers and visitors have no authority to instruct staff in job performance and duties.
- Is vigilant in reporting real or perceived safety hazards to staff or management. Is not degenerate, talk down to, ridicule, or scream at fellow golfers, visitors, staff members, or management and does not create unnecessary divisiveness in any way.
- Does not misrepresent their position or authority to others.
- Follows the published dress code.
- Complies with all facility rules. Complies with golf staff, bar staff, maintenance staff, and/or management staff.
- Does not interfere with the ability of customers and/or staff to use the golf course for its intended purpose.
- Acknowledges that only alcoholic beverages purchased at the facility are permitted on the premises.
- Management reserves the right to deny membership for any reason, or revoke membership as a result of violating the Member Code of Conduct or showing any disrespect in any manner whatsoever to a fellow member, visitor, manager, staff, agent and/or employee.
- All membership payments are non-refundable. Southern Hills Golf Club does not guarantee refunds or credits for any reason, including but not limited to relocation, injury, illness, or personal circumstances. Management reserves the right, at its sole discretion, to review individual situations and may elect to provide a partial or prorated refund as a courtesy. Any such consideration shall not establish a precedent or obligation for future cases.

ABSOLUTELY NO OUTSIDE ALCOHOL WILL BE ALLOWED ON THE COURSE. VIOLATION MAY INCLUDE LOSS OF MEMBERSHIP!

Southern Hills Golf Club 2026 Cart Agreement Form

Members(s) acknowledge and agree to the following:

1. All private carts stored on the property are for use of those on the membership only. Other riders will be charged appropriately if they choose to ride the privately-owned cart.
2. All maintenance & or repairs of privately-owned carts will be at the expense of the owner. Southern Hills Golf Club or its affiliates will not be held liable for damage due to negligence, weather, or any other damage that may happen on the course.
3. Guest may ride in a private cart provided they have paid their appropriate fees. If a guest does not check in and is not canceled from the tee time the members account will be billed.
4. Members shall drive in a responsible manner, observing all the rules and regulations, which include driving no closer than 30 feet to any green, hazard, water, or ground under repair areas. Carts are not to be driven past any white stakes. These mark private property. All cart signs must be obeyed, and any weather related rules must be followed.
5. Members who have a permit are able to operate a cart while on the golf course only. Burn outs and "whipping kitties" will not be tolerated.
6. Riding on the club storage part of the golf cart is prohibited.
7. Any property damage or physical injury caused to or by the cart while it is in the care, custody, and control of any operator shall be the responsibility of the operator. The members hereby agree to indemnify the Southern Hills Golf Course and its affiliates and hold them harmless of any and all liability.
8. Failure to comply with any of the above stated rules may result in the loss of membership with no refund.
